- 6) All dogs are to be fitted with a collar with a tag showing the name of dog and telephone number of the owner.
- 7) Dogs must be a breed, size and disposition suitable to the area of the property on which they will be contained. Large and/or aggressive dog breeds are not permitted to kept on the Estate (as per the Prohibited Large and/or Aggressive Dog Breed List).
- 8) Adequate Dog fencing to be installed by an approved MECCEMA fencing contractor prior to the dogs coming onto the Estate.
- 9) A clear picture of the dog/s to accompany this registration form.
